- 3) The Board reserves right to review, modify, revoke conditions and vary the validity period of CFO of the industry.
- 4) In case of any false certification, non-compliance of conditions / directions and deficiency in furnishing the information by the industry, the Board can withdraw the auto renewed consent and take action under provisions of relevant Acts & Rules including forfeiture of Bank Guarantee.
- 5) Under auto renewal system, the industry shall apply atleast 30 days before the expiry of the existing consent order for further renewals.

Conditions:

The industry shall comply all conditions stipulated in the Schedule A,B & C of Consent Order No : TSPCB/ZO/RCP/BLRM/55/W&A/2015-982, Dt: 03.09.2013.

The industry shall develop a minimum of 5mtrs width green belt all around the boundary of the unit and in vacant places with tall growing trees with wide leaf area. The area allocated for greenbelt shall not be less than 33 % of total area of industry.
