- 1) The Board hereby renews the Consent for Operation (CFO) of the industry, issued vide reference 1st cited, for a period upto 28.02.2021 under 25/26 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and rules made thereunder.
- 2) This consent is issued under the auto renewal system of the Board vide reference 2nd cited and as per the self certificate submitted by M/s. Azmera Gopal White Clay Mine, Sy.No. 61/2 & 62/2 of Rallapet (V), Rebbena (M), Adilabad District, vide ref. 3rd cited.
- 3) The Board reserves right to review, modify, revoke conditions and vary the validity period of CFO of the industry.
- 4) In case of any false certification, non-compliance of conditions / directions and deficiency in furnishing the information by the industry, the Board can withdraw the auto renewed consent and take action under provisions of relevant Acts & Rules including forfeiture of Bank Guarantee.
- 5) Under auto renewal system, the industry shall apply atleast 30 days before the expiry of the existing consent order for further renewals.

Conditions:

1. The industry shall comply all conditions stipulated in the Schedule A & B of Consent Order No : TSPCB/ZO/RCP/NZB/307/W&A/2015--897, Dt: 22.04.2015.
2. Greenbelt shall be developed along the boundary of mining lease area with tall growing trees, with the native species in consultation with the local DFO/Agriculture Department. The area allocated for greenbelt shall not be less than 33 % of total area of industry.
