

- 1) The Board hereby renews the Consent for Operation (CFO) and Hazardous Waste Authorization (HWA) of the industry, issued vide reference 1st cited, for a period upto **31.05.2021** under 25/26 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and rules made thereunder, Renewal of Authorization under Rule 5(4) of the Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2008 and Amendment thereof.
- 2) This consent is issued under the Auto Renewal System of the Board vide reference 2nd cited and as per the self certificate submitted by M/s. Navadurga Enterprises Private Ltd, vide reference 3rd cited.
- 3) All the conditions stipulated in the CFO & HWA order issued vide reference 1st cited holds good. The Board reserves right to review, modify, revoke conditions and vary the validity period of CFO of the industry.
- 4) In case of any false certification, non-compliance of conditions / directions and deficiency in furnishing the information by the industry, the Board can withdraw the auto renewed consent and take action under provisions of relevant Acts & Rules including forfeiture of Bank Guarantee submitted by the industry for Rs. 52,400/-, vide BG No.164430 dt:13.04.2016, with validity upto 12.04.2017.
- 5) The industry shall renew the above mentioned Bank Guarantee upto the period of the consent validity i.e., 31.05.2021 and submit the same at Regional Office RC Puram.
- 6) Under auto renewal system, the industry shall apply atleast 30 days before the expiry of the existing consent order for further renewals.
