- 3) All the conditions stipulated in the CFO & HWA order issued vide reference 1st cited holds good. The Board reserves its right to review, modify, revoke conditions and vary the validity period of the CFO& HWA of the industry.
- 4) In case of any false certification, non-compliance of conditions / directions and deficiency in furnishing the information by the industry, the Board can withdraw the auto renewed consent and take action under provisions of relevant Acts & Rules including forfeiture of the Bank Guarantee submitted by the industry for Rs.11,240/- vide BG.No.11530002416, dt.23.02.2016 with validity upto 22.02.2017.
- 5) The industry shall renew the above mentioned Bank Guarantee upto the period of Consent validity i.e., upto 31.03.2021 and submit the same at RO, RR-II.
- 6) The industry shall install & operate IP camera with PAB, TILT Zoom, 5x or above focal length, with night vision capability at HTDS & LTDS effluent collection system as per CPCB norms.
- 7) Under auto renewal system, the industry shall apply atleast 30 days before the expiry of the existing consent order for further renewals.
