The Board vide reference 4<sup>th</sup> cited, issued Circular dt. 23.10.2020 regarding online processing of applications of Consent for Operation (CFO) under Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981; Authorisation under Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 (HWA); Authorization / Renewal under E-Waste (Management) Rules, 2016 (EWA) and Registration / Renewal under Plastic Waste Management Rules, 2016 (PWA) through TS-iPASS/ OCMMS and issue of Common order for CFO, HWA, EWA and PWA.

The DPIIT, Gol has raised query with respect to Fee associated for the services i.e. Authorization under Hazardous Waste, Plastic Waste and E-waste Rules.

In view of the above and in continuation to the Board Circular dt. 23.10.2020, the following is clarified with regard to fee payable for processing of applications:

*Payment of Fee:*

*The applicant shall pay the prescribed Consent Fee along with Application for CFO under Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 only.*

*No fee is prescribed for processing the application for Authorisation under Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016; Authorization / Renewal under E-Waste (Management) Rules, 2016 and Registration / Renewal under Plastic Waste Management Rules, 2016.*

All the concerned Board Officials shall continue to follow the above procedure.
