Pavan Enterprises, T.S Agro HMT Road, Dwarakapuri Colony, Chintal, Quthbullapur, Medchal-Malkajgiri District – Complaint received from local residents of Dwarakapuri Colony, Chintal, Quthubullapur regarding air pollution caused by the industry - Operating industry without obtaining CFE & CFO of the Board as required under Water (Prevention and Control of Pollution) Act, 1974 and under Air (Prevention and Control of Pollution) Act, 1981 - **CLOSURE ORDERS – ISSUED** – Reg.

1. **WHEREAS**, you are operating the industry in the name of **M/s. Pavan Enterprises, T.S Agro HMT Road, Dwarakapuri Colony, Chintal, Quthbullapur, Medchal-Malkajgiri District** and involved in fabrication & engineering activity including spray painting.
2. **WHEREAS**, vide reference 1<sup>st</sup> cited, the Hon'ble NGT, Chennai issued orders that operating the unit without valid "Consent" is against the provisions of Water Act as well as Air Act.
3. **WHEREAS**, vide reference 2<sup>nd</sup> cited, CPCB issued certain directions to Telangana State Pollution Control Board "not to continue operations of the industries, till they obtain Consent of Operation (CFO)"
4. **WHEREAS**, vide reference 3<sup>rd</sup> cited, the Board has received a complaint from local residents of Dwarakapuri Colony, Chintal, Quthubullapur regarding air pollution caused by your industry in the surrounding area.
5. **WHEREAS** vide reference 4<sup>th</sup> cited, the Board officials have inspected the unit and surrounding areas on 18.12.2019 and observed the following:
  - i. The industry is operating without obtaining CFE and CFO of the Board.
  - ii. The industry is involved in fabrication & engineering activity including spray painting which falls under orange category.
  - iii. The industry is carrying out spray painting activity openly thereby causing air pollution in the surrounding area.
6. **WHEREAS**, vide reference 5<sup>th</sup> cited, the TSPCB, Regional Office, Medchal-Malkajgiri District has issued Show Cause Notice on 27.12.2019 to the industry for operating without obtaining CFE and CFO of the Board.
7. **WHEREAS** vide reference 6<sup>th</sup> cited, the EE, RO, Medchal-Malkajgiri District has forwarded the report to this office for taking further necessary action.

8. **WHEREAS**, vide reference 7<sup>th</sup> cited above, the Zonal Office, Hyderabad has conducted Legal Hearing before the Zonal office, TF Committee on 12.02.2020 at Zonal Office, T:S Pollution Control Board, Begumpet, Hyderabad. After detailed discussions and careful consideration of material facts of the case, the committee recommended to issue closure orders to the industry for the following reasons:
- The industry is operating without obtaining the Consent for Establishment (CFE) and Consent for operation (CFO) of the Board.
  - The industry is carrying out spray painting activity openly and causing air pollution in the surrounding area.
9. After careful consideration of all material facts of the case, the Board is of the firm opinion that the industry is operating without obtaining CFE and CFO of the Board and causing air pollution to the surroundings, hence violating the Water (Prevention and Control of Pollution) Amendment Act, 1988 & Air (Prevention and Control of Pollution) Amendment Act, 1987. Under the Powers vested with the T.S. Pollution Control Board under section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987 for the reasons stated supra, **the Board hereby issues closure orders to your industry**, in the interest of protecting public health and environment.
10. You are directed to take note that if you continue to operate your unit even after receipt of this orders, you will be liable for prosecution in the court of Metropolitan Magistrate or Judicial Magistrate of the first class under section 41(2) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 37 (1) of Air (Prevention and Control of Pollution) Amendment Act, 1987, the punishment for which includes imprisonment for a term which shall not be less than one year six months which may be extended to six years and with fine.
11. You are further directed to take note that the TSSPDCL has been ordered to disconnect Power Supply to your industry with immediate effect. Should you resort to run your industry by means of diesel generator or any mechanical device, you will be attracting prosecution under Section 41(2) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under Section 37(1) of Air (Prevention and Control of Pollution) Amendment Act, 1987.

Under the powers vested under section 33(A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987, the TSSPDCL is hereby directed by TS Pollution Control Board to disconnect the Power supply to M/s. Pavan Enterprises, T.S Agro HMT Road, Dwarakapuri Colony, Chintal, Quthbullapur, Medchal-Malkajgiri District with effect from the date of this order.

The T.S Pollution Control Board has issued closure orders to M/s. Pavan Enterprises, T.S Agro HMT Road, Dwarakapuri Colony, Chintal, Quthbullapur, Medchal-Malkajgiri District under section 33(A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987, as the industry is operating without obtaining CFE and CFO of the Board and causing air pollution to the surroundings, thereby violating the Water (Prevention and Control of Pollution) Amendment Act, 1988 & Air (Prevention and Control of Pollution) Amendment Act, 1987.
