Gopal, Nelabanda Thanda, Bodagutta Thanda Gram Pacnchayat, Balanagar (M), Mahabubnagar District - Water (Prevention and Control of Pollution) Amendment Act, 1988 - Air (Prevention and control of Pollution) Amendment Act, 1987 - Operating the unit without consents of the Board and causing pollution in the surrounding areas - **Closure Orders - Issued - Reg.**

1. WHEREAS, you are operating the industry located at Bodagutta Thanda Gram Pacnchayat, Balanagar (M), Mahabubnagar District and engaged in processing of purified lead and lead ingots.
2. WHEREAS, the Hon'ble NGT-Chennai while delivering the judgment in OA No.106 to 112 of 2016, mentioned that operating the industry without "Consents" is against the provisions of Water & Air Acts.
3. WHEREAS, the CPCB issued directions to the Telangana State Pollution Control Board "not to continue operations of the industries, till they obtain Consent for Operation (CFO)".
4. WHEREAS, a telephonic complaint was received from MPP, Balanagar Mandal, Mahabubnagar District against Lead recycling units located at Balanagar Mandal area and regarding air pollution being caused in the surroundings.
5. WHEREAS, the Board officials inspected the units situated at Balanagar Mandal area on 27.11.2019 and also met the MPP, Balanagar Mandal. He informed that, the Lead Recycling units causing air pollution in the surrounding areas. There are 6 Lead Recycling units found in Balanagar Mandal area. Your unit is one among the units identified.
6. WHEREAS, the Board officials inspected your unit on 27.11.2019 and observed the following :
  - The industry has not kept any display boards and it was learnt that the unit is operated by Sri K. Gopal r/o Nelabanda Thanda with power connection Service (Meter No. P00900737).
  - The industry is operating without obtaining CFE & CFO of the Board.
  - The industry has 2 Nos. of Mandir Bhattis for which provided common APCE i.e. Multi Cyclone followed by bag filter. The industry has not provided chimney for dispersion of flue gases at higher elevation.
  - During the inspection, the Air Pollution control equipments were not in operation and smoke is spreading to the surroundings.
  - The industry is storing Raw materials / solid waste on naked ground without storage shed.
  - The industry is not maintaining records pertaining to production, solid waste generation and its disposal, etc.
  - The industry has not provided separate energy meter to the Air Pollution Control Equipment (APCE) and not maintaining records.

7. WHEREAS, the Board issued a show cause notice to the unit on 30.11.2019 for operating without consents of the Board and you have failed to reply to the show cause notice till date.
8. After careful consideration of material facts of the case, the Board is of the firm opinion that you are operating the industry without consents of the Board and causing Air pollution in the area. In view of likelihood of further grave injury to the environment & public health and hence, the Board hereby decided to dispense with opportunity of hearing. Under the Powers vested with the T.S. Pollution Control Board under section 33 (A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987 for the reasons stated above, the **Board hereby issues closure orders to your industry** in the interest of protecting public health and environment. You are also hereby directed to stop all industrial activities with immediate effect from the date of this order.
9. You are directed to take note that if you continue to operate your industry even after receipt of this orders, you will be liable for prosecution in the court of Metropolitan Magistrate **or** Judicial Magistrate of the first class under section 41(2) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 37 (1) of Air (Prevention and Control of Pollution) Amendment Act, 1987, the punishment for which includes imprisonment for a term which shall not be less than one year six months which may be extended to six years and with fine.
10. You are further directed to take note that the TSSPDCL, has been ordered to disconnect the Power Supply to your industry with immediate effect. Should you resort to run your industry by means of diesel generator **or** any mechanical device, you will be attracting prosecution under section 41(2) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 37 (1) of Air (Prevention and Control of Pollution) Amendment Act, 1987.
