**Sub:** TSPCB – ZO - Hyderabad – M/s. Tulsi Food Products, 8-1-707/1/263, Sy.No.160, 162, 163/1, 164 & 165/1, Plot No.263, Tata Nagar, Mylardevpally, Rajendranagar (M), Rangareddy District - Water (Prevention and Control of Pollution) Amendment Act, 1988 & Air (Prevention and Control of Pollution) Amendment Act, 1987 – Hon'ble High Court PIL No.398 of 2012 filed by Sri P. Vinay Palnitkar, Shastripuram Colony, Shivrampally, Kattedan, Rajendranagar (M), Rangareddy District regarding shifting of illegal godowns, workshops and warehouses in open areas which are dealing in recycling of plastic - Operating the industries without obtaining consent of the Board, Operating the industries in 10 kms radius of Himayatsagar and Osmansagar Lakes and causing Air & Water pollution in the surrounding area – **CLOSURE ORDERS – ISSUED** – Reg.

1. **WHEREAS**, you are operating the industry in the name of M/s. Tulsi Food Products, 8-1-707/1/263, Sy.No.160, 162, 163/1, 164 & 165/1, Plot No.263, Tata Nagar, Mylardevpally, Rajendranagar (M), Rangareddy District which is involved in Food Processing (Chocolates and Wafers).
2. **WHEREAS**, you are operating your unit without having Consent for Operation (CFO) of the Board as required under Section 25/26 of Water (Prevention & Control of Pollution) Act, 1974 and under Section 21/22 of Air (Prevention & Control of Pollution) Act, 1981, thereby non complying with the Environmental Regulations.
3. **WHEREAS**, vide reference 1<sup>st</sup> cited, the Hon'ble NGT in Appeal Nos. 106 to 112 of 2016 (SZ) has directed to issue closure order to the industries for operating without obtaining CFO of the Board and located within 10 Kms radius of Himayatsagar and Osmansagar lakes.
4. **WHEREAS**, vide reference 2<sup>nd</sup> cited, a PIL was filed in Hon'ble High Court PIL No.398 of 2012 by Sri P. Vinay Palnitkar, Shastripuram Colony, Shivrampally, Kattedan, Rajendranagar (M), Rangareddy District regarding shifting of illegal godowns, workshops and warehouses in open areas which are dealing in recycling of plastic.
5. **WHEREAS**, vide reference 5<sup>th</sup> cited, the Board officials inspected the industries located in Sasthipuram & Tata Nagar on 05.03.2020 & 07.03.2020 and it was observed that the industry is situated in 10 kms radius of Himayatsagar & Osmansagar lakes, operating without

Consent for Establishment (CFE) / Consent for Operation (CFO) of the Board and causing air & water pollution in the surrounding area which is also violation of G.O.Ms.No.111.

6. **WHEREAS**, vide reference 8<sup>th</sup> cited, the EE, RO-I, Rangareddy District has forwarded the report to this office for taking further necessary action.
7. After detailed discussions and careful consideration of material facts of the case, the Board is of the firm opinion that you are operating the industry without consents of the Board in 10 Kms radius of Himayatsagar and Osmansagar Lakes and causing Air & Water pollution in the area. In view of likelihood of further grave injury to the environment & public health and hence, the Board hereby decided to dispense with opportunity of hearing. Under the Powers vested with the T.S. Pollution Control Board under Section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under Section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987 for the reasons stated supra, **the Board hereby issues closure orders to your industry**, in the interest of protecting public health and environment.
8. You are directed to take note that if you continue to operate your unit even after receipt of this orders, you will be liable for prosecution in the court of Metropolitan Magistrate or Judicial Magistrate of the first class under section 41(2) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 37 (1) of Air (Prevention and Control of Pollution) Amendment Act, 1987, the punishment for which includes imprisonment for a term which shall not be less than one year six months which may be extended to six years and with fine.
9. You are further directed to take note that the TSSPDCL has been ordered to disconnect Power Supply to your industry with immediate effect. Should you resort to run your industry by means of diesel generator or any mechanical device, you will be attracting prosecution under Section 41(2) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under Section 37(1) of Air (Prevention and Control of Pollution) Amendment Act, 1987.

The orders will take effect from today i.e., 12.03.2020

Tulsi Food Products, 8-1-707/1/263, Sy.No.160, 162, 163/1, 164 & 165/1, Plot No.263, Tata Nagar, Mylardevpally, Rajendranagar (M), Rangareddy District** with effect from the date of this order.

The T.S Pollution Control Board has issued closure orders to **M/s.
