  5. TSPCB, RO-I, Rangareddy District issued Show Cause Notice on 03.12.2019.
  6. Analysis reports received on 20.11.2019.
  7. TSPCB, RO, Ramagundam report dt. 21.12.2019 received by Zonal Office, Hyderabad on 23.12.2019.
  8. Task Force Committee meeting held on 03.01.2020 at TSPCB, Zonal Office, Hyderabad.

1. **WHEREAS**, you are operating the industry in the name of **M/s. Raja Rajeshwara Industries, Sy. No.193/1, 193/2, 177A/7 & 192/8, Sankenapalli (V), Velgatoor (M), Jagityal District** which is a paboiled Rice mill with 32 TPD capacity.
2. **WHEREAS**, vide reference 1<sup>st</sup> cited, the Hon'ble NGT, Chennai issued orders that operating the unit without valid "Consent" is against the provisions of Water Act as well as Air Act.
3. **WHEREAS**, vide reference 2<sup>nd</sup> cited, CPCB issued certain directions to Telangana Sate Pollution Control Board "not to continue operations of the industries, till they obtain Consent of Operation (CFO).
4. **WHEREAS**, vide reference 3<sup>rd</sup> cited, a complaint was received by regional office through Prajavani forwarded from District Industries Centre, Jagtial made by Sankenapalli villagers, Sankenapalli (V), Velgatoor (M), Jagtial District through mail on 05.11.2019 & 29.11.2019 regarding causing of Air pollution & smell nuisance in the surroundings of the units.
5. **WHEREAS**, vide reference 4<sup>th</sup> cited, the Board Officials inspected the unit on 30.11.2019 and observed the following:
  - i. The unit was not yet obtained CFO.
  - ii. The unit was not in operation at the time of inspection. But it appeared that it was, in general in operation.
  - iii. The unit not has not yet constructed ETP.
  - iv. The unit has provided Husk shed & Ash shed.
  - v. The unit discharged untreated waste water onto the lands.

6. **WHEREAS**, vide reference 5<sup>th</sup> cited, the Regional Office has issued Show Cause notice to the unit on 03.12.2019. But, the unit not yet replied.
7. **WHEREAS**, vide reference 6<sup>th</sup> cited, the analysis reports of untreated effluent found discharged on the adjacent land indicates that the values of TSS and BOD exceeding the limiting standards.
8. **WHEREAS**, vide reference 7<sup>th</sup> cited, the EE, Regional Office, Ramagundam has forwarded a detailed report with the above observations to Zonal Office Hyderabad for further necessary action.
9. **WHEREAS**, vide reference 8<sup>th</sup> cited, the issue was placed in the task force committee meeting held on 03.01.2020 at Zonal Office, Hyderabad. The committee after detailed discussion recommended to **issue directions** to the industry to comply within **15 days**:

As per the recommendations of the committee, the Board hereby issues the following directions to the industry to comply within **15 days**:

- The unit shall operate only after obtaining CFO.
  - The unit shall immediately stop discharging untreated water on to the lands.
  - The unit shall provide full fledged ETP with all machinery before starting the operations.
  - The unit shall provide all requirements of a parboiled unit as per CFE and then apply for CFO.
  - The unit shall ensure that there shall not be any complaint in future with regard to the any kind of nuisance to the surroundings.
  - The unit shall ensure that there shall not be exceeding of analysis values of any sample from prescribed standards.
10. **In view of the above, the industry is hereby directed to comply with the above directions within 15 days.** These directions are issued under Section 33(A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and under Section 31 (A) of Air (Prevention and Control of Pollution) Amendment Act, 1987.
  11. It is also to note that, if it is continued to operate the unit violating any of the conditions mentioned above, the unit will be closed under Section 33(A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988, Section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987 and you will also be liable for prosecution in the court of Metropolitan Magistrate or Judicial Magistrate of the first class under Section 41(2) of the Water (Prevention and Control of Pollution) amendment Act, 1988, the punishment for which includes imprisonment for a term which shall not be less than one year six months and which may be extended to six years with fine.
