- I. The SEIAA, AP (Combined State) issued EC order vide reference 1st cited, for the proposed 1.00 Ha. Building Stone and Road Metal Quarry Mine (1,71,513 cum/annum), of Sri T. Krishnarjun Reddy, Sy.No. 439/1, Chintagattu (V), Hasanparthy (M), Warangal District for mining 1,71,513 TPA of Building Stone and Road Metal Quarry Mine.
