- I. Earlier, the SEIAA, AP (Combined State) vide reference 1<sup>st</sup> cited had issued Environmental Clearance for **5.60 Ha. Colour Granite Mine of M/s. Sharath Granites, Sy. No. 69, B.B.Rajpally (V), Gollapally (M), Jagityal District** for mining 2,708 m<sup>3</sup>/annum of Colour Granite.
- II. M/s. Sharath Granites, vide reference 2<sup>nd</sup> cited informed that the Mine lease has been transferred from M/s. Sharath Granites to M/s. Craft Stone (P) Limited and submitted copy of Procds. dt. 26.11.2013 of ADMG, Karimnagar transferring mining lease, along with Affidavit on Rs. 100/- Stamp papers dt.05.08.2017 by M/s. Craft Stone (P) Ltd., for Transfer of EC and Undertaking that they will comply all statutory stipulations as per EC and E(P) Act, 1986. Hence, it was requested to transfer the EC in the name of M/s. Craft Stone (P) Limited.
- III. The above issue was examined by the SEAC in its meeting held on 23.09.2017 and State Level Environment Impact Assessment Authority (SEIAA) in its meeting held on 16.10.2017. The Authority approved to transfer the EC order already issued in favour of M/s. Sharath Granites to M/s. Craft Stone (P) Limited. **The SEIAA, Telangana hereby transfers the EC order issued vide reference 1<sup>st</sup> cited, in the name of M/s Craft Stone (P) Limited, with all terms and conditions stipulated therein remain the same.**
