The Hon'ble National Green Tribunal (SZ), Chennai in its order dated: 24.10.2017 while disposing of the Application No.69 to 72/13 and batch cases, popularly known as " Patancheru Pollution Batch Matter cases" has passed orders with certain directions to be followed by the State Government and State Pollution Control Board. With reference to the above orders of Hon'ble NGT, dated:24.10.2017 the TSPCB has directed the Chief Accounts Officer of TSPCB to create "Patancheru and Bollaram Environment Relief Fund (PBERF)", vide memo 5th read above.

2. Accordingly, an account in favour of "M/S Patancheru and Bollaram Environment Relief Fund" was opened with Andhra Bank, A.P. Secretariat Branch (1103) with A/c No. 110310100040810 TSPCB, Sanathnagar, Hyderabad.

3 The Telangana State Pollution Control Board (TSPCB) has also submitted proposals vide his letter 1st and 6th read above for constitution of Committee for taking a decision to utilize the Corpus Fund named PBERF for restoration of the Environment in the entire attached areas of Patancheru and Bollaram industrial area.
