1. WHEREAS, you are operating the stone crusher located at Gopalpur (V), Elkathurthy (M), Warangal Urban District and engaged in Stone Crushing activity.
2. WHEREAS, the Board vide order dated 04.02.2016 issued closure order to your unit for operating the industry without having valid consent of the Board and not taken adequate Air Pollution Control measures.
3. WHEREAS, vide letter dated 24.02.2020, you have requested the Board for CFO and revocation of closure orders.
4. WHEREAS, the Board vide order dated 10.06.2020 issued CFO to your unit which is valid upto 31.03.2025.
5. WHEREAS, the Board Officials inspected your unit on 17.03.2020 and observed the following:
 - i. The industry has provided cladding to the vibrating screen and arranged water sprinklers at crushing section and on all conveyors for arresting dust emissions.
 - ii. The industry has provided elevated closed dust bunker and covered the dust bunker conveyor belt with GI sheet.
 - iii. The industry has developed thick greenbelt all around the crusher to the extent of 3.25 Acres out of the total area of 6.25 Acres.
6. The Board after careful consideration of all facts of the case, hereby extend the temporary revocation of Closure orders for a further period of **Six Months from the date of this order** with the following conditions:
 - i. The crusher shall comply with all conditions stipulated in the CFO order issued by the Board.
 - ii. The crusher shall provide and maintain the following as committed during the meeting and ensure that there will not be dust / air pollution from the unit.
 - a. Cladding to the crushers, vibratory screen & conveyor belt.
 - b. Mechanical water sprinklers at all the dust generation sources.
 - c. Elevated closed bunker for collection of dust
 - d. Metal / Concrete roads within the crusher premises.
 - e. Temporary wind breaking walls all around the crusher.
 - iii. The Crusher shall develop / maintain adequate green belt by planting more No. of broad leaved indigenous tree species to control dust / air pollution in the surrounding area.
 - iv. The unit shall revalidate the BG with a validity period of one year before its expiry till further orders from the Board.

7. The T.S.N.P.D.C.L has been directed to extend the restoration of power supply to your unit temporarily for a further period of **Six Months from the date of this order**.
8. These orders are issued under Section 33(A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and under Section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987.
9. You are hereby directed to note that, should you misuse these orders to operate the unit violating any of the conditions mentioned above, your unit will be closed under section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987. You will also be liable for prosecution in the court of Metropolitan Magistrate **or** Judicial Magistrate of the first class under section 41(2) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 37(1) of the Air (Prevention and Control of Pollution) Amendment Act, 1987, the punishment for which includes imprisonment for a term which shall not be less than one year six months and which may be extended to six years with fine.

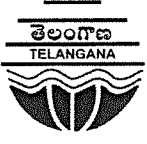

In the 1st reference mentioned above, orders under section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 31(A) of Air (Prevention and Control of Pollution) Amendment Act, 1987 were issued to T.S.N.P.D.C.L to disconnect the power supply to M/s T. Madhavarao Stone Crusher, Gopalpur (V), Elkathurthy (M), Warangal Urban District.

In the 2nd reference cited, the unit has represented for revocation of closure orders. After careful consideration of all facts of the case, the Board has decided to issue temporary revocation of closure orders for a period of **Six Months from the date of this order.**

The Board hereby directs the T.S.N.P.D.C.L to restore power supply to M/s T. Madhavarao Stone Crusher, Gopalpur (V), Elkathurthy (M), Warangal Urban District temporarily for a period of **Six Months from the date of this order** for carrying out the production activities. The T.S.N.P.D.C.L is directed not to extend the power supply beyond the period mentioned above without prior orders of T.S. Pollution Control Board. These directions are issued under section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 31(A) of Air (Prevention and Control of Pollution) Amendment Act, 1987.
