1. **WHEREAS**, you are operating the unit in the name of M/s. United Pet Industries, M-223, IDA Kattedan, Rangareddy District and engaged in Pilfer proof caps, PP caps & Plastic bottles by using virgin granules / plastics.
2. **WHEREAS**, vide reference 1<sup>st</sup> cited, the Hon'ble NGT in Appeal Nos. 106 to 112 of 2016 (SZ) has directed to issue closure order to the industries for operating without obtaining CFO of the Board and located within 10 Kms radius of Himayatsagar and Osmansagar lakes.
3. **WHEREAS**, vide reference 2<sup>nd</sup> cited, you are operating the unit in prohibited area of 10 Kms radius of Himayatsagar and Osmansagar Lakes.
4. **WHEREAS**, vide reference 4<sup>th</sup> cited, the Board officials inspected the industries located in Kattedan on 20.03.2020 and it was observed that the industry is situated in 10 kms radius of Himayatsagar & Osmansagar lakes, operating without Consent for Establishment (CFE) / Consent for Operation (CFO) of the Board and causing air & water pollution in the surrounding area which is also violation of G.O.Ms.No.111.
5. **WHEREAS**, vide reference 5<sup>th</sup> cited, the Board has issued a Show cause notice to the unit on 20.03.2020 for operating without obtaining consents of the Board, unauthorized operation in 10 Kms radius and causing air & water pollution in the surrounding areas which is effecting the public health and environment.

6. **WHEREAS**, vide reference 6<sup>th</sup> cited, the Board has issued Closure orders to the unit on 18.05.2020 for operating the unit without CFO of the Board, unauthorized operation in 10 Kms radius and causing air & water pollution in the surroundings areas which is effecting the public health and environment.
7. **WHEREAS**, vide reference 7<sup>th</sup> cited, the industries submitted a representation for revocation of closure orders issued by the Board.
8. **WHEREAS**, vide reference 8<sup>th</sup> cited, the Environmental Engineer, Regional Office-I, Rangareddy District submitted the report pertaining to the request made by the industry for revocation of closure orders issued by the Board. As per the report of the EE, RO-I, Rangareddy District, the industry was established before 22.12.2000 and submitted the following proof of their establishment before year 2000.
  - i. The industry has submitted GM, DIC SSI Registration dated 05.11.1976.
9. **WHEREAS** vide reference 9<sup>th</sup> cited, the Chairperson, TSPCB issued instructions vide note dated 03.07.2020 that Green category industries i.e., established before 2000 and submitted documents of establishment prior to the Hon'ble Supreme Court order dated 22.12.2000 in CA Nos.368-371 and 373 of 1998 after obtaining an undertaking that the existing industry will be shifted outside the 10 km radius, as and when State Government so directs.
10. **WHEREAS**, vide reference 10<sup>th</sup> cited above, the Board conducted Hearing before the Zonal office, Task Force Committee on 10.07.2020 at Zonal Office, Telangana State Pollution Control Board, Begumpet, Hyderabad. After detailed discussions and careful consideration of material facts of the case, the committee recommended **to issue revocation of closure orders** to the industry.
11. **WHEREAS**, vide reference 11<sup>th</sup> cited, the industry has submitted an undertaking on Rs.100/- stamp paper that the industry shall shift from the existing premises outside the 10 km radius of Himayath sagar and Osman sagar lakes, as and when State Government or the Board so directs. The industry shall abide to the policy of the Government regarding relocation of the industry from time to time.
12. After careful consideration of all material facts of the case available on records, the Board hereby issues **Revocation of Closure Orders** to your unit, under section 31 (A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987 and under section 33 (A) of the Water (Prevention & Control of Pollution) Amendment Act, 1988 with the following directions to comply with.
  - a) The industry shall shift outside the 10 km radius of Himayath sagar and Osman sagar lakes, as and when the State Government so directs. The unit shall abide to the policy of the Government regarding relocation of the industry from time to time.
  - b) Concealing the factual data or submission of false information / fabricated data and failure to comply with any of the conditions mentioned in this order may result in

withdrawal of this order and attract action under the provisions of relevant pollution control Acts.

13. The TSSPDCL has been directed to restore Power Supply to your unit.
14. You are hereby directed to note that you should not misuse these orders to operate your unit without complying with the above conditions and the provisions of Water and Air Acts, your unit will be closed under Section 31 (A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987 and under Section 33 (A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988, and you will be liable for prosecution under section of Air 37 (1) of Air (Prevention and Control of Pollution) Amendment Act, 1987 under section 41(2) of Water (Prevention and Control of Pollution) Amendment Act, 1988, the punishment for which includes imprisonment for a term which shall not be less than one year six months and which may be extended to six years with a fine.

The order will come into effect from today i.e., 16.07.2020
