1. WHEREAS, you are operating the industry located at Sy No. 524,525, Amisthapur (V), Bhoothpur (M), Mahabunagar District and engaged in seed processing.
2. WHEREAS, the Board vide order dated 08.02.2018 issued Closure orders to your unit on 07.02.2020 for operating without CFE / CFO of the Board.
3. WHEREAS, You have represented the Board for revocation of closure orders stating that de-linting season of cotton seed is over and have stopped the de-linting soon after receiving the closure orders. The industry requested for revocation of closure orders for operating activities like seed processing, grading & packaging & Packing of cotton seed, Paddy, Mize, Red Gram and Jowar etc., only.
4. WHEREAS, the Board vide order dated 23.04.2020 issued CFO to your unit for the following products which is valid upto 31.03.2021 :

Sl No.	Product	Quantity
1	Paddy Seed	425 Kgs/day
2	Maize Seed	950 Kgs/day
3	Cotton Seed	900 Kgs/day
4	Red Gram	240 Kgs/day
5	Millet Seed	45 Kgs/day
6	Husk (by product)	50 Kgs/day

5. WHEREAS, You have again represented vide mail dated 25.04.2020 requesting to restore the power supply for operating only seed processing unit and not to operate de-linting activity.
6. Whereas, the EE.RO.Hyderabad submitted the latest status on the request of the Industry vide report dated 25.04.2020.
7. After careful consideration of material facts of the case, the Board hereby revokes the closure orders to your unit with the following conditions:
  - i. The unit shall comply with all the CFO conditions issued by the Board.
  - ii. The industry shall not operate the de-linting activity. If the industry is found operating de-linting activity, Closure orders will be issued without any further notice.
  - iii. The unit shall not cause any air pollution is the surroundings due to the operations of the unit

8. The T.S.S.P.D.C.L has been directed to restore the power supply to your industry.
9. These orders are issued under Section 33(A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and under Section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987.
10. You are hereby directed to note that, should you misuse these orders to operate the unit violating any of the conditions mentioned above, your unit will be closed under section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987. You will also be liable for prosecution in the court of Metropolitan Magistrate or Judicial Magistrate of the first class under section 41(2) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 37(1) of the Air (Prevention and Control of Pollution) Amendment Act, 1987, the punishment for which includes imprisonment for a term which shall not be less than one year six months and which may be extended to six years with fine.
