1. **WHEREAS**, you are operating the industry located at Sy.No.266, Industrial Park, Sofinagar, Nirmal (V & M), Nirmal District and involved in manufacturing of Parboiled Rice – 25.0 TPD & Byproducts: Rice Husk – 4.0 TPD, Rice Bran – 4.0 TPD & Broken Rice – 3.0 TPD.
2. **WHEREAS**, vide reference 1st cited, the Board issued closure order to your industry for operating the industry without valid CFO of the Board.
3. **WHEREAS**, vide reference 2nd cited, the Board issued renewal of CFO to your industry on 07.10.2020, for a period upto 30.09.2028.
4. **WHEREAS**, vide reference 3rd cited, the RO, Nizamabad Officials informed that the industry has obtained CFO & HWA order, provided ETP & requested to issue of revocation of closure order.
5. **WHEREAS**, after careful consideration of all the material facts of the case, the Board hereby issue revocation of closure orders to your industry with following conditions to comply:-
 - i. The industry shall comply with the conditions stipulated in CFO & HWA order issued vide dt. 07.10.2020 scrupulously.
 - ii. The industry shall not operate without valid CFO&HWA of the Board and shall apply for renewal of the consent prior to its expiry.
6. The TSNPDC., Ltd., has been directed to restore the power supply to your industry.
7. These directions are issued under Sec.33 (A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987.

You are hereby directed to note that, should you misuse these orders to operate the unit violating any of the conditions mentioned above , your unit will be closed under section 33(A) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 and section 31(A) of the Air (Prevention and Control of Pollution) Amendment Act, 1987 without any further notice to you and you will also be liable for prosecution in the court of Metropolitan Magistrate or Judicial Magistrate of the first class under section 41(2) of the Water (Prevention and Control of Pollution) Amendment Act, 1988 & under section 37(1) of the Air (Prevention and Control of Pollution) Amendment Act, 1987 the punishment for which include imprisonment for a term which shall not be less than one year six months and which may be extended to six years with fine.

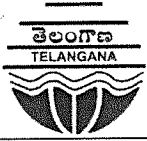

In the 1st reference mentioned above, orders under section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 31(A) of Air (Prevention and Control of Pollution) Amendment Act, 1987 were issued to TSSPDCL to disconnect the power supply to **M/s. Sri Thirumala Balaji Boiled Rice Mill, Sy.No.266, Industrial Park, Sofinagar, Nirmal (V & M), Nirmal District.**

Vide reference 2nd cited, the RO, Nizamabad Officials informed that the industry has obtained CFO & HWA order, provided ETP & requested to issue of revocation of closure order to the industry.

After careful consideration of all the material facts of the case, it was decided to revoke the closure orders issued to the industry. Accordingly, the Board issued revocation of closure orders to the industry vide reference 3rd cited. A copy of the revocation of closure order is herewith enclosed.

In view of the above, the Board hereby directs the TSNPDCL to restore the power supply to **M/s. Sri Thirumala Balaji Boiled Rice Mill, Sy.No.266, Industrial Park, Sofinagar, Nirmal (V & M), Nirmal District.** These directions are issued under section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under section 31(A) of Air (Prevention and Control of Pollution) Amendment Act, 1987.
