- As per the Judgement dt.24.10.2017 of the Hon'ble NGT in Application No. 69 of 2013 (SZ) (THC); Application No. 70 of 2013 (SZ) (THC); Application No. 71 of 2013 (SZ) (THC); Application No. 72 of 2013 (SZ) (THC); Application No. 86 of 2013 (SZ) (THC); Application No. 87 of 2013 (SZ) (THC); Application No. 88 of 2013 (SZ) (THC); Application No. 89 of 2013 (SZ) (THC); Application No. 91 of 2013 (SZ) (THC); Application No. 82 of 2013 (SZ) (THC); Application No. 90 of 2013 (SZ) (THC) at page no. 352 under para 12 it is stated that "all existing units shall have their primary effluent treatment system inside the unit, whether they are Members of CETP or not and the same has to be scrupulously enforced by the Regulatory Authority".

- The proponent should carryout mining operations maintaining atleast 250m from the nearest human habitation of Mailaram. The proponent should develop & maintain greenbelt in the buffer area left towards Mailaram, in addition to the greenbelt to be developed all along the boundary of the mine lease area. The proponent should take all precautionary measures committed vide his lr.dt.16.04.2018.


The SEIAA examined the representation of the proponent dt.10.04.2018 and after detailed discussions, the following observations are made:

- It is noted that the proponent has filed an Appeal No.84 of 2017 in Hon'ble NGT Chennai aggrieved by the rejection order issued by the SEIAA.
- It is informed that the Hon'ble NGT has given final judgement on 24.10.2017 in Application No. 69 of 2013 (SZ) (THC); Application No. 70 of 2013 (SZ) (THC); Application No. 71 of 2013 (SZ) (THC); Application No. 72 of 2013 (SZ) (THC); Application No. 86 of 2013 (SZ) (THC); Application No. 87 of 2013 (SZ) (THC); Application No. 88 of 2013 (SZ) (THC); Application No. 89 of 2013 (SZ) (THC); Application No. 91 of 2013 (SZ) (THC); Application No. 82 of 2013 (SZ) (THC); Application No. 90 of 2013 (SZ) (THC) wherein the NGT has not put any ban on industry and allowing industries for expansion as well as the establishment of new industries by inflicting some remedial measures. However, it is noted that the said Appeal No.84 of 2017 is not covered in the Hon'ble NGT order dt. 24.10.2017.
- Thus, as of now the matter is pending disposal before the Hon'ble NGT Chennai.
