OFFICE ORDER

In pursuance to the Hon'ble NGT Order dated 16.05.2017 in the matter of Original Application No.471 of 2016, filed by People for Education and Research Scholarship and Outward Nutrition, New Delhi Vs MoEF&CC, UOI, New Delhi & another, the State Government has examined the matter and issued Notification vide Government Order GO Ms No. 35, dated 27.09.2017, in exercise of the powers conferred under sub-section 3 of Section 19 of the Air (Prevention and Control of Pollution) Act, 1981, (Central Act, 4 of 1981), declaring that "Pet Coke" as fuel does not require to be prohibited in the State of Telangana, subject to installation of air pollution control system by the industries using Pet Coke, so that, pollution control norms are adhered to by every such industry.

Accordingly, the Telangana State Pollution Control Board has examined the issue and Pet Coke is considered as 'an approved fuel' under Section 2 (d) of the Air (Prevention and Control of Pollution) Act, 1981, subject to the following conditions: -

1. That it shall be an approved fuel in case of industrial units where the Consent under the provisions of the Air (Prevention and Control of Pollution) Act, 1981, have been specifically issued for utilization of Pet Coke.
2. The industries will be required to install all the requisite air pollution control systems & take all air pollution control measures so as to achieve the emission standards for SO₂ emission and providing minimum stack height, as prescribed in Schedule-I of the Environment (Protection) Rules, 1986, framed under the Environment (Protection) Act, 1986, as amended from time to time.
3. That the industries shall comply with all the conditions as laid down in the Consent Order issued under the provisions of the Air (Prevention and Control of Pollution) Act, 1981.
4. That the industries shall comply with all the directions issued by the Board under the provisions of the Air (Prevention and Control of Pollution) Act, 1981.
